- 108.1 Road Restriction Discussion about weight limits, one way system, traffic consultation by the highways, traffic from construction site, and poor signage on A10 for numerous road closures in recent months mostly Stow Bridge. Concluded additional HGV traffic in recent months may be attributed to the numerous road closures and poor signage. Hopefully with less road closures this should ease. We will monitor the situation for 3-6 months. If we see signs of increase in HGV movement in the village we will speak to highways and ask them to monitor/consultation.

We are to add the new bottom trod onto the grass cutting list to make sure it doesn't get over grown. **Clerk to arrange with holly Landscapes.**

IJMC attended_AGM on behalf of PC. All in good order and reworking some of the larger plots to smaller ones. A small waiting list, but they are full and in good order. If needed we should send a letter of support to the bank to let them know that it is not a business.

General feeling that it was a great community event and that more should be organised. The family of the Lancaster bomber crew gave a donation of £150 to the recreation ground to do something in support. JH engineering has been contacted and to have something with the Lancaster and names of the crew in a solid steel bench. However, this likely to be £700-£1000. 116.2 Applications Received

23/00955/F Construction of new dwelling at 24 Lynn Road Wimbotsham King's Lynn Norfolk PE34 3QL

Object: PC acknowledge the revised proposals represent an improvement on the previously submitted scheme. However, the PC objection remains on the basis of access as previous:

Object to an additional dwelling and its access onto Lynn Road which is close to a busy junction (Church Road) with poor visibility, the profile of the road combined with the speed of traffic and other hazards such as bus stop makes this a dangerous location for an additional access.

No objection to the principle of a dwelling, provided:

It maintains a reasonable proportion of the important gap in the street scene. It is requested that the lower element is reduced further in height/girth (Say 500mm) to give a greater impression of space and sky scape in the street scene.

It is in scale with the adjacent dwellings (which are all modest semi-detached with narrow girth and therefore modest roof scapes. The above suggested revision would help achieve this to overcome PC objection.

At present the proposed dwelling meets neither of the above criteria, being a large detached dwelling with prominent double garage with no vernacular design elements, filling most of the existing gap in the street scene. It is therefore out of scale and keeping with the area.

The sash windows are a welcome revision, though marginal glazing bars are not typical of the local vernacular and therefore remain out of keeping. Vertical central glazing bars are a suggested revision and would be more in keeping.

The dwelling does not appear to have any chimney stacks, which are typical of the street scene and vernacular. Addition of chimney stacks (false) to the gable ends of main roof would be more in keeping for a vernacular style dwelling in the location.

The proposed dwelling does not maintain or enhance the character of the Conservation Area due to its design and location. With the above suggested revisions, the design would be considered more acceptable.

There is a light out outside Emilys cottage in Tinkers Lane, can we please have it fixed. Also, there is a lot of overgrown vegetation on the corner at the back of the pub, as you go down Tinkers Lane. It may be owned by the pub, needs to be checked and then ask the owner if they can cut it back.

Methodist Church step and lighting. To ask why the light has not been replaced? We can maybe get assistance for funding for lighting and roadway from the Norfolk County Council Parish Partnership Fund.
